In a construction delay claim, the contractor has the burden to prove that the offending party's actions affected activities on the critical path of the contractor's performance of the contract. *George Sollitt Const. Co. v. U.S.*, 64 Fed.CI. 229 (Fed. CI. 2005). To meet this burden, a contractor must initially establish the as-planned critical path. Moreover, the critical path needs to be diligently updated to adapt to the evolution of the construction project as it is actually built. Critical Path Method (CPM) schedules are the most often used and preferred way to create and document the critical path.
