Next month, I have the opportunity to preside over the 13th Annual Raymond J. Ehrlich Trial Advocacy Seminar through the Jacksonville Bar Association. Being chosen to chair this signature event was a great honor in large part because it is an opportunity to pay respect to a great man who has paved the path for lawyers like me to follow. Justice Ehlrich had a reputation of being a lawyer's lawyer and

someone who chased his dreams. He was a proud son of a Jacksonville and WWII Navy veteran. During his time as the Chief Judge of the Florida Supreme Court, he oversaw a major renovation and expansion of the Supreme Court Building and released a major study of gender bias in the Florida legal system that led to significant reforms in the law and legal culture affecting women. Ehrlich was known as a studious Justice who put in long hours, worked most weekends, and always wore a signature bowtie. He was greatly admired in the legal community and among government officials. In a 1988 article in the *Florida Bar Journal*, former Gov. LeRoy Collins spoke of his own appreciation of Ehrlich, stating, "He symbolizes as much as any person I know," Collins said. "The term 'integrity'." How many people would you say that about?

I hope to put on an event that would have garnered his approval. We have some great speakers lined up on very timely legal topics. I'll be moderating a "Bet the Company" litigation panel in the morning and presenting the Justice Raymond J. Ehrlich Professionalism Award to this year's recipient at our monthly bar lunch. In the afternoon, we'll have a panel of eight trial and appellate judges asking each other questions they've always wanted to ask. Thereafter we'll have a presentation on jury focus groups, and we'll conclude with another panel covering "Media Relations in Courtroom Proceedings" featuring Judge Debra Nelson. Judge Nelson is best known for presiding over the State v. George Zimmerman trial pertaining to the shooting death of Trayvon Martin. I trust that Judge Nelson will have some interesting things to say about her experiences in dealing



Mortgage foreclosures in Florida took an interesting twist in December 2014, due to the recent decision in Deutsche Bank Trust Company, et al. v. Beauvais, et al. This decision effects the time period for bringing foreclosure claims in the event of acceleration and a prior dismissal of a foreclosure lawsuit.

Section 553.781, Florida Statutes, provides a measure to require design professionals and contractors comply with the Building Code. The Legislature found that accountability for work performed by design professionals and contractors is the key to strong and consistent compliance with the Florida Building Code and, therefore, protection of the public health, safety, and welfare was required. The legislature enacted 553.781 to provide such accountability.

Hot Chocolate Day





J&C gets in shape with circuit training




