Once eligibility was confirmed, rankings for the list were determined according to gross revenue by Kahuna Accounting, an independent accounting firm.

Earlier this year, Jimerson & Cobb was recognized by Jacksonville Business Journal for their fourth consecutive year as one of the 50 fastest-growing companies in Northeast Florida, so this award gave Managing Partner Charles Jimerson another opportunity to comment on the firm's unprecedented growth.
