Regretfully, I've been everyone in that video at one point in time, save for the ambivalent stenographer. Sometimes a little less melodramatic, sometimes a little more. I always enjoy the mental volley with obstructive witnesses in depositions. Some witnesses will intentionally try to evade, or argue with you about each important question. More than others, these witnesses require your patience and persistence. When the witness gives an evasive answer to my question, it's commonplace for me pursue the line of questioning until I obtain a responsive answer. That usually requires me to narrow the questions and rephrase them so that the witness is required to answer it despite pesky "asked and answered" objections. At some point it may become a battle of wills. If that is a fight I want to fight, I'll persist. If it is not, I'll choose to fight a more important one at a later point in time.

An argumentative witness will often try to anticipate where you are going with each question and defeat your objective. He will quibble with small details and try to evade when he cannot quibble. I treat these witnesses just like the evasive witness. Questions are just repeated or modified to eliminate objectionable details. If a witness claims he doesn't understand my terms, I either define the term or ask him to define the term and then repeat the question. Eventually, he will break down and answer. If necessary, I'll use pinning techniques to make sure I have answers that can be used to impeach at trial.

As for the video above, it's a rarity for us lawyers to trade such gems. In reality, most depositions involving good lawyers and sophisticated parties have a natural flow and

few animated moments. Any good lawyer would tell you that the deponent's counsel should not have been portrayed as bumbling and timid. The witness was stonewalling at his lawyer's direction, and doing quite well at it. Note that the defendant's lawyer objects to tone of questioning early on only, but not afterwards - despite the addition of louder vocals and aggressive body language. Good attorneys are skilled at keeping exasperation to a minimum. If this had gone to court, such a display could have turned a jury against Plaintiff's counsel. No seasoned litigator should ever lose his cool like this. Rather, you should just keep asking the same question, over and over and over, until you get the answer you are after. Be mentally stronger than the adversary.

Truth is, this deposition would have likely been noxiously mundane like most of the depositions in complex multi-party litigation. Unless you are lucky enough to have one of those days where it becomes those few select war stories that would make for a solid transcript dramatization. Those are the days where you sit back and enjoy the sport of it. Remind me to tell you about a few of my deposition battles next time we bump into each other. My favorite was the executive of the publicly traded company who said, "I don't remember," 468 times in a six-hour deposition. I let him dig himself into a hole he could never get out of. At the conclusion of the deposition, I said, "Thank you for your time. I love listening to lies when I know the truth." I then placed a large stack of documents that contradicted his testimony in front of him as we exited. The case settled a month later for everything my client was asking for.

J&C case continues to gain attention of press

A J&C case continues to be featured in news headlines, as its legal twists and turns have many unsure as to what will happen next.

Former Jacksonville businessman and Circle K Furniture owner Jose Lantigua was traveling in Venezuela last April when he unexpectedly passed away. Within a month, the estate was involved in litigation to settle up \$10 million in bills.

J&C represents a regional bank, which was pledged first rights on an insurance policy of Lantigua's for \$2 million. What initially began as a standard insured-benefits case turned into a much more complex matter when an investigative company for the insurance company revealed that they had reason to believe Lantigua was alive and well and living in Venezuela. If true, the insurance company would have basis to deny the bank's claim to the policy.

Yet another twist recently revealed that the investigative company itself fraudulently manufactured and misrepresented evidence to support their denial of the claim. J&C, along with attorneys for the Lantigua estate, recently went to court to accuse the insurance company of fraud and to ask for the entire case to be thrown out.
