Charles B. Jimerson sends special thanks to Hurricane Irma this Thanksgiving

This Thanksgiving, I'd like to send special thanks to someone/something I have dogcussed for a couple of years now: Hurricane Irma. With a stroke of luck, my family and I will move into our new home next month after being displaced for two years and three months from Hurricane Irma. For those who did not know of our circumstances, our house took on knee deep water and had to be bulldozed when it lost its structural integrity. My family lost almost all of our personal possessions in the flood and have been foreshortened and subjugated nomads ever since.

We have not been in our family home since we awoke to the St. Johns River trespassing in our living room in the pre-dawn hours of September 11, 2017. The last night we will ever spend in the house that brought my family together ended with the rudest awakening I have had since my military days. That was an important point in time for my



family- a watershed moment if you will. Sorry, I'm a dad and can't avoid the temptation of a sugary, beguiling pun.

I can joke about it now because I'm incredibly thankful for the opportunity that the last two years have presented. Theodore Roosevelt once said, "Life brings sorrows and joys alike. It is what a man does with them, not what they do to him, that is the true test of his mettle." Mettle can be defined in numerous ways and tested at many levels during life's unpredictable and bumpy journey. A few words come to mind when I think about mettle: courage, spirit, character, nerve, heart, resolve, grit, and vigor. At the end of the day I believe the mettle test can be best summarized as to how we handle our ups and downs, which in turn helps define our character.

As I reflect on my life, I can clearly identify many situations where I have failed when my mettle was tested, but I also know that many other times I was able to rise to the occasion. I always try to learn from my shortcomings while maintaining a serious dose of gratitude and humility. Hurricane Irma presented me with a lot of learning opportunities, the most significant was the prospect of teaching my two children under 6 about how to be resilient when your mettle is tested. For the last two years, my family has chosen to treat this two-year displacement as an adventure. We've packed our family into two different condos and enjoyed a transitory view of cosmopolitan living. Well, at least as cosmopolitan as Jacksonville, Florida can live. Using adversity as our education, we turned our wounds into wisdom and made healthy choices to be thankful for the ability to be together. Like a fighter training for a main event fight, it was actually grounding to reduce your foundation to your trimmed down fighting weight. It gave us a nice reminder that we didn't need the excess fat so long as we served as each other's cornermen. Fighters we are and fight we did. Nothing cleanses your soul like getting the hell kicked out of you.

Hurricane Irma taught my family that a challenge only becomes an obstacle when you bow to it. To be tested is good. Life's challenges are not supposed to paralyze you, they're supposed to help you discover who you are. For us, it helped us define what it means to be a Jimerson - what it means to not let

outside events have power over your own mind. Anyone can give up or feel sorry for themselves; it is the easiest thing in the world to do. But to hold it together when everyone would expect or not fault you for falling apart, now that is true strength.

One of the core tenets of my approach to life is that choice, not chance, determines destiny. Life presents you with so many decisions, so many choices. Choices are not always easy. Some we regret, some we're proud of. Some will haunt us forever. Some we really lucked out on. Some define us and our very being. Most of the time, there is a right and wrong choice, with the right choice being right in front of your face, if you will just step back and see it. Every choice you make makes you, and for the Jimersons, we made the choice that we couldn't cross that river simply by staring at the water.

The Jimersons learned that our family is what we made it to be. And our family is strong, not by the number of heads counted at the dinner table, but by the loving instincts every family member helped create, by the memories we've shared, by the commitment of time, caring, and love we show to one another, and by the hopes for the future we have as individuals and as a unit. By being in over our head, we all got to learn how tall we were. So, this Thanksgiving we share our thanks with Hurricane Irma. Your opportunity knocked and we have answered. My only ask is that next time will you please not knock so hard on my new door?

Together, they reviewed and discussed the market implications of local government impact fees in northeast Florida with professionals focused on municipal planning and finance from all over the country.



Market Implications Impact fees are multiplied to home buyer o If fee is charged at development, it becomes part of the "Finished Lot" price, which means the house price has to increase 4x to support the fee. If fee is charged at permit, it becomes part of the "Construction" amount, which means the house price has to increase 2x to support the fee
